

OFFICIAL RULES
“SpaStakes” Sweepstakes

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT
INCREASE YOUR CHANCES OF WINNING.**

ELIGIBILITY: Sweepstakes is open only to legal U.S. residents (excluding residents of Puerto Rico and U.S. territories and possessions), 18 years of age or older who are principals or employees of those spas and/or salons which are members of both the SpaFinder and Spa & Salon Wish Partner Programs and who are entering on behalf of the owner(s) of those spas and/or salons. Employees of SpaFinder, Inc., and its parent, affiliates, subsidiaries, and advertising and promotion agencies, and immediate family members (spouse, sibling, child, parent and each of their respective spouses, regardless of where they reside) and persons living in the households of such persons, whether or not related, are not eligible to enter or win a prize.
