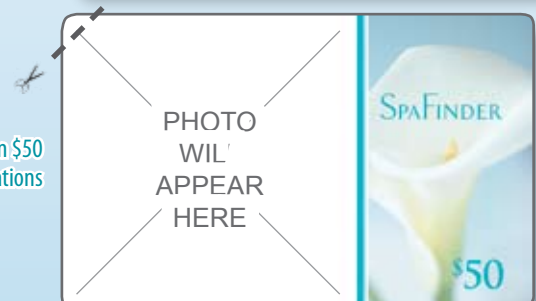

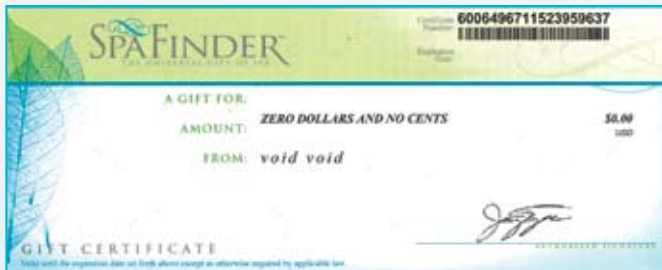
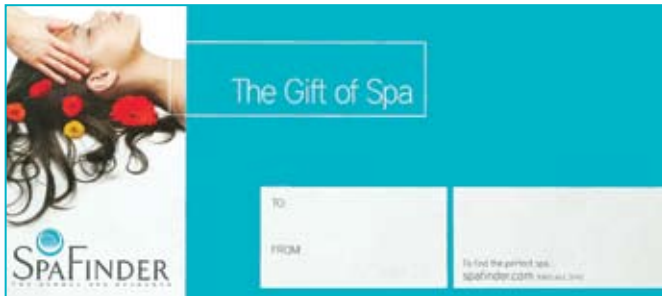

You may accept SpaFinder gift certificates and cards for accommodations, services and products.

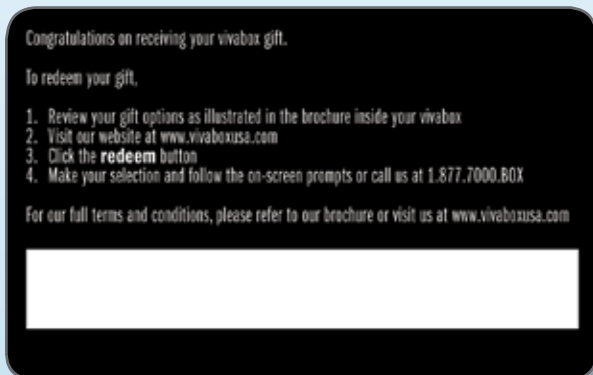
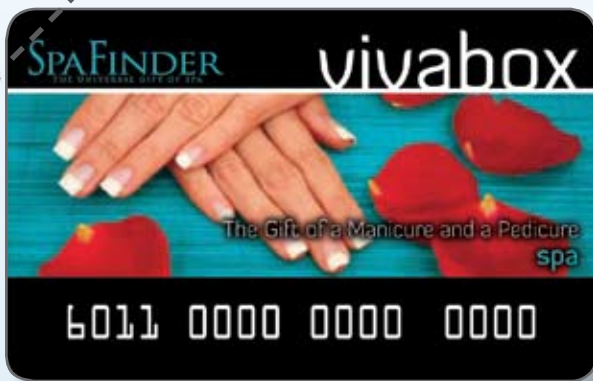
1. Look for the SpaFinder logo on the certificate.
2. If an expiration date is printed on the gift certificate, you may honor it up to six weeks past that date.
3. If full balance is not completely used issue **your own store credit or gift certificate/card**.
4. Check for a 3D Hologram only on Hallmark issued gift certificates.
5. **Photocopy** then separate the two portions of the certificate. Retain top portion and copies for your records for at least six months.
6. Handwrite **VOID** across the bottom part.

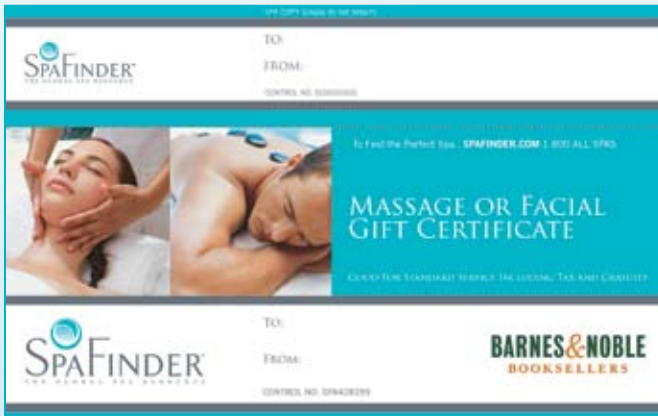
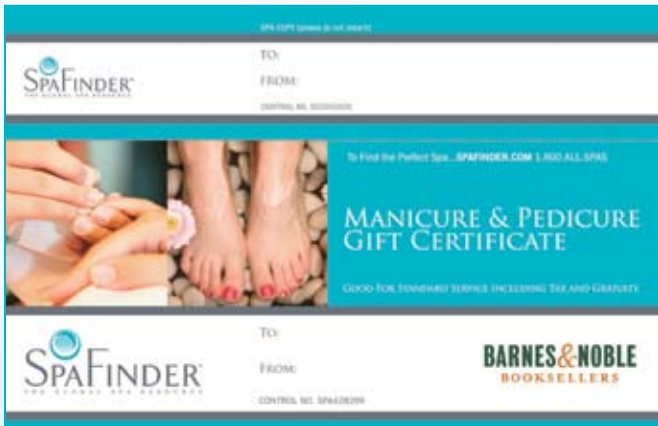
