

OFFICIAL SWEEPSTAKES RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

Spafinder Sweepstakes (the "**Sweepstakes**") begins on March 19, 2018 at 12:00am Eastern Time and ends on April 30, 2018 at 11:59pm Eastern Time (the "**Sweepstakes Period**"). The Sweepstakes is jointly run by Spafinder, Inc. and Blackhawk Network. (the "**Sponsors**"). For the purposes of the Sweepstakes, the "**Sweepstakes Group**" is composed of the Sponsors and their respective affiliates and related companies, including without limitation their parent, sister and subsidiary companies, retailers, franchisees, advertising and promotion agencies, suppliers of material and services related to the Sweepstakes, and any other corporation, partnership, sole proprietorship or other legal entity directly involved in the Sweepstakes and their respective officers, directors, employees, agents, and other representatives.
